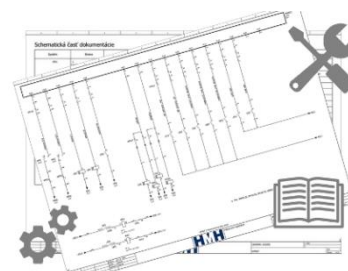

Functional and safety aspect of integration must be considered within integration of MIREL VZ1 Train Protection.

Integration of MIREL VZ1 Train Protection into driving rail vehicle can be carried out only by an integrator. Integrator is the Producer of Train Protection, or a subject authorized by Producer.
